AUCTION SALE NOTICE

Sealed tenders in Plain Papers are invited by the undersigned from intending bidders for purchase of Government Jeep bearing Registration No. OR-02C-3925 of the office of the Dy. Director of Factories & Boilers, Rayagada Division, Rayagada with an Up set price of Rs. 48,000/- (Rupees Forty Eight Thousand only).

The intending bidders can inspect the vehicle in the office premises of the undersigned located at : Near block office, Rayagada prior to submission of tender paper by them in any working days during office hour between 10:00 A.M. to 01:00 P.M.

The bidders shall furnish Earnest Money Deposit of Rs. 1,000/- (Rupees One Thousand) only in shape of Bank Draft in favour of the Assistant Director of Factories & Boilers, Rayagada Zone & DDO of the Office. This will be refunded to the unsuccessful bidders. The EMD furnished by the highest bidder shall be adjusted against sale price of the vehicle.


"Tender paper for purchase of condemned vehicle", shall be written on the top of the sealed cover containing the tender paper. The last date of receiving sealed tender/ auction sale in the office of the Dy. Director of Factories & Boilers, Rayagada Division, Rayagada on 26.07.2022 till 05:00 P.M. at the latest and tenders so received shall be opened by the Tender Committee on 27.07.2022 at 04:30 P.M. in presence of the tenderers or their authorized agents. The tenderers shall produce their identity proof on the scheduled date and time before opening of tenders.

The highest bidder whose tender would be accepted shall deposit immediately 25% of the bid amount as initial deposit. Thereafter, he shall deposit the balance amount within seven days of the deposit of the initial amount and remove the vehicle with the permission of the undersigned. In case he fails to make the deposit of the total amount as per the tender within the stipulated time his initial deposit including the earnest money shall be forfeited. GST as admissible shall be levied on the bidding price.

The bidders / tenderers shall remove the vehicle from the site, within seven days from the date of depositing the full amount of bid / tendered money. Custody and safe guard of the vehicle shall be the responsibility of the bidder / tenderers and no claim or complaint on that account shall be admissible.

In case the bidder, whose tender could be accepted, failed to remove the vehicle from the office campus within stipulated time, he shall pay ground rent @1% of his quoted price per day. If the ground rent so charged exceed the amount deposited by the highest bidder on the date of opening of the tender, then the bidder shall seize to have any right on the vehicle and the amount deposited by him shall be adjusted towards ground rent.

The authority reserves the right to accept / reject any or all tender at any time without assigning any reason thereof.
